VOLUNTEER WAIVER AND RELEASE FORM

RELEASE OF LIABILITY

*All volunteers must complete and submit the Waiver and Release Form before volunteer placement.

The **volunteer** (hereafter referred to using "I", "me", or "my") in this agreement.

- I have agreed to volunteer with World Partners for Development-Ghana (WPD-Ghana) in Ghana at my own free will. Also, I am 18 years old or more, and I am aware of my chosen volunteer position and activities.
- I understand that the scope of my relationship with WPD-Ghana is limited to a volunteer position and that no compensation is expected in return for services provided by me.
- I understand and agree that, I am responsible for my own insurance coverage in the event of personal injury or property damage as a result of my volunteer services with WPD-Ghana, and will not hold WPD-Ghana responsible for any injury or property damage arising out of the Volunteer Activities, even if caused by their ordinary negligence or otherwise.
- I represent that, to my knowledge, I am in good health and suffer no physical impairment that would or should prevent my participation in Volunteer Activities.
- I also agree to indemnify and hold harmless WPD-Ghana for all claims arising out of my participation in the Volunteer Activities.
- I understand that participation in the Volunteer Activities involves certain risks, including, but not limited to, injury and death. I am voluntarily participating in the Volunteer Activities with knowledge of the danger involved and I agree to accept all risks of participation.
- I grant and convey to WPD-Ghana all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice derived from the volunteering activities to be used in future brochures, website and other advertising materials.
- I understand that this document is intended to be as broad and inclusive as permitted by the laws of the Greater Accra Region of Ghana in which the Volunteer Activities take place and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect.
- I also understand that this document is a contract which grants certain rights to and eliminates the liability of WPD-Ghana.

Waiver and Release:

I the undersigned Volunteer release and forever discharge and hold harmless WPD-Ghana and its officers, directors, employees, sub-contractors, host families, sponsors, partners, agents and affiliates from all present and future claims that may be made by me, my family, estate, heirs, or assigns for property damage, personal injury, wrongful death arising as a result of my participation in the Volunteer Activities in Ghana, whenever or however the same may occur.

I am of legal age and I have read this form and understand that by signing this form, I express my understanding and intent to enter into this Release and Waiver of Liability willingly and voluntarily.
